### Hillsdale Christian School

PURPOSE: Hillsdale Christian School was established by its founders to make available a school which would work in harmony with the home and church in educating young people in all areas of life – spiritual, intellectual, social, and physical.

PHILOSOPHY: The philosophy of Hillsdale Christian School is based on a God-centered view that all truth is God's truth and that the Bible is the inspired and only infallible, authoritative Word of God containing this truth. As an educational institution, Hillsdale Christian School believes bringing up a child in Christ-likeness is primarily the responsibility and biblical duty of the parent. Our school exists, therefore, to assist in that education, working together with the family and church. The curriculum of Hillsdale Christian School arises from our philosophy that places God, not man, in the center of all things.

We believe in the virgin birth of Jesus Christ and His Deity, His sinless life, His crucifixion, His bodily resurrection, His ascension to the Father where He is now in the presence of God acting as our intercessor (Isaiah 7:14, Matthew 1:23, Hebrews 4:7, 15, 26, John 10:30, 1Corinthians 15:3, Ephesians 1:7, John 11:35, 1Corinthians 15:4, Mark 16:19).
- 4. We believe that man was created in the image of God by the direct will of God (Genesis 1:26, 28, Genesis 5:1-2).
- 5. We believe that because of the fall of Adam, all men are born in sin and in need of a Savior (Romans 3:23, John 3:16-19).
- 6. We believe that we are saved by grace through faith in Jesus Christ, God's only begotten Son who shed His blood on the cross in atonement for our sins and our eternal salvation (Ephesians 2:8-10, Romans 5:8-9).
